THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS 1104 LYONS PLACE

THIS THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS

AND RESTRICTIONS is made effective the \_\_\_\_\_ day of \_\_\_\_\_\_, 2008, by PARK LAND

OF NORTH CAROLINA, LLC (the "Developer").

### WITNESSETH:

THAT WHEREAS, the Developer on July 15, 2005, caused to be filed a Declaration of Covenants, Conditions and Restrictions ("Declaration") in Book 1097 at Page 0317, Granville County Register of Deeds, governing the ownership and occupancy of residential properties located in 1104 Lyon's Place; and

WHEREAS, the Developer on April 10, 2006 caused to be filed a First Amendment to Declaration of Covenants, Conditions and Restrictions ("First Amendment") in Book 1141 at Page 386; and

WHEREAS, the Developer on June 12, 2006 caused to be filed a Second Amendment to

Declaration of Covenants, Conditions and Restrictions ("Second Amendment") in Book 1152 at Page 504, Granville County Register of Deeds; and

WHEREAS, the Developer finds it necessary to further clarify the provisions of the Declaration pertaining to 1104 Lyons Place Subdivision concerning the restrictions of outbuildings, fences and vehicles located adjacent to the back and side line of the properties and construction of the structures; and

WHEREAS, Developer has conveyed directly to contractors or indirectly through contractors to residents title to Lots 1, 2, 3, 4, 5, 6, 7, 8, 12, 13, 15, 17, 19, 22, 23 and 27, and continues to hold title to Lots 9, 10, 11, 14, 16, 18, 20, 21, 24, 25, and 26; and

WHEREAS, the Declaration provides that Developer may amend the Declaration at any time so long as it owns any property in the development area and has the votes and written consents of two-thirds of the lot owners signing this Third Amendment; and

WHEREAS, the signatories constitute more than two-thirds of the lot owners.

NOW, THEREFORE, the Developer, with the required lot owner consent, hereby amends the Declaration as follows:

1. Article 13, Paragraph C. shall be amended to read as follows:

"No above-grade structure (except approved fences or walls) may be constructed or placed on any lot except within the minimum building set back lines as set forth herein a) twenty-five (25') feet from the lot front line, b) six (6') feet from the lot side line with a total minimum of fifteen (15') feet, and c) ten (10') feet from the lot rear line.

The term "lot front line" defines the boundary line of the lot that is contiguous to and bounded by the named street as shown on the recorded subdivision plat.

The term "lot rear line" defines the boundary line of the lot that is farthest from, and

substantially parallel to, the line of the street on which the lot abuts.

The term "lot side line" defines the boundary line of the lot that extends from the street on which the lot abuts to the rear line of the lot.

The owner of the lot and a portion of all adjoining and contiguous lot or lots may construct a dwelling and/or structures permitted hereunder upon and across the dividing line of such adjoining an contiguous lots, all such structures to comply with the minimum building set back lines of the actual boundary lines of the subject Owner's property, and thereafter such combinations of lots or portions thereof shall be treated for all purposes under these restrictions as a single Lot. All wire fences shall be coated with a plastic or vinyl coating".

- 2. Article 13, Paragraph E. (2.) shall be amended to read as follows:
- "No mobile home, trailer, camper, tent, or temporary house, temporary garage or other temporary outbuilding shall be placed or erected on any Lot, provided, however, that boats and recreational vehicles may be parked in back of or to the rear of residences and the Committee may grant permission for temporary structures for storage of materials during construction. No such temporary structure as may be approved shall be used at any time as a permanent residence."
- 3. Article 13, Paragraph E. (5.) shall be amended to read as follows: "All dwellings and permitted structures erected or placed on any Lot shall be constructed of material of good grade, quality and appearance, and all construction shall be performed in good workmanship manner and quality. The foundations of all dwellings shall be natural stone or brick. No used structures will be relocated or placed on any Lot and no structure shall have an exterior constructed of concrete blocks, asbestos or asbestos siding or like material. Any permitted outbuilding shall be of the same material, quality, general appearance and workmanship as the dwelling on the Lot. The requirements of the Committee shall control all improvements to any

Lot as is therein specified."

Except as the Declaration are amended by this Third Declaration, the provisions of the Declaration of Covenants, Conditions and Restrictions for 1104 Lyons Place Subdivision as recorded in Book 1097 at Page 315, and as amended by the First Amendment recorded in Book 1141 at Page 386 and by the Second Amendment recorded in Book 1152 at Page 504, shall be and remain the same.
